Board of Trustees Meeting: 2/13/17

1. Opening Words and Check In

2. BOT Goals: Technology

Sean initiated a discussion of this particular BOT goal by identifying 5 key principles that provide a road map for moving forward. [See attachment.] Taken together, these principles focus upon "people investment" rather upon capital requirements. Subsequent discussion noted that technology "means different things to different people" and that identifying "primary purposes" is critical for identifying next steps. Identified purposes for further discussion:

- Opportunity to grow membership
- Internal communications
- Easing financial transactions
- Cost Containment

3. Meet-up Group Site

Rob referred to a new member's suggestion that we initiate a "meet-up group" site via social media. Sean will follow up.

4. 2017-18 Budget

Peter led an initial review of our current budget as well as a budget planning document as a first step in preparing the '17-'18 year budget. The current budget assumes a \$45k deficit which should not be replicated. Among the other factors for consideration:

- No Fiber Fest revenue
- Settled minister compensation
- Compensation/benefit increases for existing staff
- Budget drive outcome
- Wish lists/Enhancements
- Physical plant needs

Discussion followed. Rob noted the importance of this year's fund drive in conjunction with the budgeting process ahead. All agreed that individual BOT members should model "Fair Share" giving in their own pledges.

5. Endowment Fund Contribution

Rob shared a thank you note from Sally Lewis for a C.A.M.P. donation through the Endowment Fund.

6. Social Action Group Rental Policy

Rob referred to the Society's mission as a reason for considering whether to offer discounted building rental rates to emerging social/political action groups. All agreed that the idea makes sense in principle but that a vetting mechanism is needed. Rev. Tony suggested that an ad hoc BOT sub-committee could serve this purpose.

Are emerging groups in need of meeting space? Jackie will report back from one such group in Wyckoff. Sean will do the same from another in Glen Rock. Additional feedback is anticipated from the upcoming meeting of the Social Responsibilities Council.

9. Anderson Hall Refurbishment

Speaking on behalf of several other Society members, Holly referred to the anticipated arrival of a new settled minister and the current condition of several décor aspects of Anderson Hall, pulpit area carpeting, among other examples. The issue of unbudgeted costs was raised. Notwithstanding Holly's generous offer of a personal donation, action will be considered in the upcoming budget process.

10. UUSC Statement of Conscience

The BOT unanimously approved a motion to invite individual members and friends of the Society to personally sign a copy of Unitarian Universalist Service Committee Statement of Conscience – the resulting document to be hung in the Fellowship Room.
