From the Interim
Minister's Mailbox

This edition of the newsletter is finalized in the middle of an exciting week, during which the members of the Unitarian Society of Ridgewood and the Rev. Dr. Sarah Lenzi get to know each other, a week that will conclude with a congregational vote on the recommendation of the Ministerial Search Committee to call Dr. Lenzi to be the next settled minister of the Society.

I write from New Braunfels, Texas, where members of the Interim Ministers Guild are gathered for its annual seminar. Several of my interim colleagues also serve congregations hearing and voting on ministerial candidates this week. More interim congregations will have candidates visit next week, and a few later in the spring. It is an exciting time for congregations and ministers.

It is also an exciting week in the Unitarian Universalist Association, whose top leadership is going through a radical transition and 603 of whose member congregations are having white supremacy teach-ins over a two to three week period. This is a time for deep introspection within the Association, among its national and regional

staff, and within its member congregations. This is the time for USR and other congregations to make real their commitment to anti-racism by examining white supremacy within our local and denominational bodies.

This is not a time for blame. It is a time for honest exploration and discussion. As with the process of calling a minister, the white supremacy teach-in is a time to live our Unitarian Universalist faith, by deeply living the principles of advancing justice, equity and compassion, by actively valuing the worth and dignity of every person, and by using the democratic process within the congregation and in society.

The disruption of leadership and challenge to business as usual are scary to many, and understandably so. But what is scary points to deeper self-understanding and truer living in the world. We are living in a time for great possibility and rebirth in Unitarian Universalism.

I think of the words of Adam Clayton Powell, Jr., congressman and preacher: "Keep the faith, baby!"

In exercising your right under congregational polity to elect your own minister and in entering the deep and life-giving work of racial justice, you are keeping the faith.

Reflections

As you all hopefully know by now, I am coming to the end of my time at USR. As a religious educator, leaving well is an important component of doing my job well. Many religious professionals learn the "Three C's" for a good departure: Closure, Celebration, and Covenant. As I see it, the Closure and Covenant pieces are mainly my responsibility. Many of you have already helped me in the Closure component - sharing kind words with me that included expression of disappointment about my departure, appreciation for my work with you, and understanding of the decision I have made. I so appreciate the generosity with which you have shared your thoughts.

As another part of closure, the RE Committee and I will do a review of what has been accomplished in the RE program during my time with you, which I will then share broadly with the congregation, in this newsletter next month and elsewhere. One more important part of closure is helping to ensure a smooth transition by setting my successor up for success to the best of my ability, which I'll get to in a moment.

As for Covenant, it is important to have a mutual understanding of what my continued relationship with individuals at USR and the congregation as a whole can be after my departure. Most generally, I am bound by the LREDA Code of Professional Practices, which reads, in part:

When leaving a position of religious education leadership for any reason, I will refrain from being involved in the process of selecting my successor. I will support my successor by leaving room for them to establish their own identity and leadership in the congregation... I will refrain from discussing any church/congregational matters on social media with congregants from a former church for a period of two years.

Partly to ensure I uphold this code as well as I can, and partly just because of the logistics of geography and family life, I do not plan to have any involvement at USR after my departure, at least for the foreseeable future. As for the process of selecting my successor, a DRE Search Committee is currently being formed by the Board of Trustees, and I encourage you to approach the Board with any questions you may have about this process.

Going back to setting my successor up for success - this includes having a full slate of volunteer religious education teachers ready to go in the fall, to give him or her time and space to get to know you all before she/he needs to undertake any recruiting efforts. To that end, the RE Committee and I will be staffing a table at Coffee Hour on May 7, May 14, and May 21 to answer any questions you might have about being an RE teacher, and to recruit teachers! Please note that anyone interested in teaching must complete a background check and pass other safe congregation measures before becoming a teacher. If you have been thinking about teaching RE but are unsure of exactly what it entails, please come talk to us! If you haven't been thinking about teaching RE, I invite you to read what follows, and then come talk to us!

As always, I'm available and happy to talk to any of you, for any reason. I'm usually in the office on Tuesdays and Fridays from 9am-3pm, and available by email at usr.dre1@gmail.com or cell phone at 207-409-6192.

WHY SHOULD YOU TEACH RELIGIOUS EDUCATION AT USR??

Maybe you never considered teaching religious education before because...

"I don't have any kids in the religious education program!"

Teaching is a great opportunity to get to know the wonderful kids in our congregation, who you might otherwise just see in passing during coffee hour. Our congregations are one of the last places in society where we can intentionally create multigenerational community, and that starts in religious education!

Traditionally, teaching has been seen as the responsibility of the parents. But consider this: always being downstairs with the kids (year after year!) prevents parents from connecting more broadly with the congregation and dedicating their time and talents to other volunteer work that they may be better suited to. It also prevents others in the congregation from forming relationships with the families at USR. So let's change "tradition"!

"I don't know the first thing about teaching!"

That's ok! In addition to receiving training before you start and ongoing support from the Religious Education Staff, you will get a detailed lesson plan to follow each week. You will always be teaching with a partner, and the Floating Teacher, RE Assistant, and DRE are also circulating on Sundays to offer support if any issues arise during class time.

"I don't know enough about Unitarian Universalism to teach RE!"

Teaching RE is a great chance to learn more about Unitarian Universalism! In fact, some teachers have reported that they learned more about our faith while teaching than at any other time. You will be provided with curriculum that contains all you need to know - you are not expected to become an expert in UU prior to teaching.

"I don't want to miss Sunday Services!"

We all agree that Sunday Services are great! What you may not know is that there are 40 Sunday services from September - June (52 if you come in the summer!), and RE Teachers only commit to teaching on 10 of those Sundays. They still get to attend 75% of the Sunday Services each year, and have the opportunity to form meaningful relationships with the children while learning a lot on the remaining 25% of Sundays.

STEWARDSHIP COUNCIL

The Planned Giving Committee is pleased to announce the grant recipients for 2017! A total of \$9,360 was awarded, as follows:

Applicant Georgetta Walsh	<u>Amount</u> \$3,000	Project/Use SHARE bathroom renovation: The USR has been an advocate and supporter of SHARE, a Seniors house which sits across the street from the Society. All 28 rooms are occupied, some by members of the USR. There is an enormous need to update the facilities. This year's grants will go to updating some of the bathrooms.
Ed Silver	\$ 750	Honduran deportees legal representation: Ed Silver has been providing pro bono representation to two children (ages 14 and 16) who are in removal proceedings — meaning that the US Government is attempting to deport them back to Honduras. Ed is affiliated with Kids In Need of Defense (KIND) and they are representing the cases on their personal capacity. The one large cost is for translators. Our funds are to be used to help in this regard.
Sally Lewis	\$ 600	CAMP Reading materials: Another organization that has had significant USR involvement is C.A.M.P., a program assisting inner city children in Paterson. Sally Lewis is one of those leaders, and has requested funds to replace books The Reading Milestone Series. These books focus on the learning disabled who are often new to the English language.
Elizabeth Ames	\$3,000	NNJSC (Northern New Jersey Sanctuary Coalition) is a humanitarian and human rights organization. Elizabeth Ames has requested funds to help support an asylum seeker in our area. Funds are used to provide medical care, ESL, job counseling, transportation, case management, socialization and counseling among other services.
Margaret White	\$2,000	Community of Friends in Action (CoFIA); Since 1999, CoFIA has operated a free lunch program in Palisades Park for day laborers who are looking for work. Abruptly last December, the Grace Evangelical Lutheran Church withdrew their offer to use their space for any activities. The organization is trying to maintain their connection with the Guatemalan workers as well as search out a new home from which to serve. Our funds are helping in this effort.

As you can see, our members do great work in the greater community and we are proud to help support such causes. As you might imagine, we could not fully fund all of the requests. We would LOVE to be able to do more and that requires all of our help. When you wish to celebrate or honor an event, think of donating to the USR Endowment Fund. When you think of honoring a deceased loved one, think of the USR Endowment Fund. When you are thinking of your estate plan, why not talk to a committee member about making the USR Endowment Fund a part of that plan? We received an overly generous bequeathment last year of \$78,000 which allowed us to greatly increase the amount available for this years' grants. Become part of our local (and needed) social action platform!

May 14th Plate Collection

The Offertory collection for the Mothers' Day service on **May 14** will be dedicated to Kids in Need of Defense (KIND). KIND's mission is to protect children who are fleeing to the United States, to ensure that no child appears in immigration court without legal representation. The non-profit organization trains and provides pro bono attorneys to represent unaccompanied immigrant and refugee children in their deportation proceedings.

Children in deportation proceedings who appear without counsel have little chance of success. KIND has trained more than 17,000 attorneys and helped more than 14,000 unaccompanied children since opening its doors in 2009. The children represented by KIND receive all legal and other services free of charge.

KIND also works on the public policy level to change laws and practices that jeopardize unaccompanied children. The organization also helps children returning to their countries of origin to reintegrate back into the communities.

Society member Ed Silver and several of his legal colleagues from Columbia University's in-house legal department are working on a pro bono case assigned by KIND. They are representing two children who fled gang violence from Central America. The children are currently facing the threat of deportation, and, if not for KIND, would very likely join the thousands of children in a courtroom, facing a government attorney, without any assistance. Ed conveys his gratitude for the opportunity to help support KIND in the performance of its critical work.

Living the Welcoming

Living the Welcoming showed the film "From This Day Forward" on April 21st which was excellent. It followed the life of a transgender woman and her family. The New York Times reviewed the film on June 23, 2016.

It depicts the marriage of Ms. Shattuck's mother, Marcia, and Michael, now Trisha, who raised Ms. Shattuck and her younger sister, Laura, largely in small-town Michigan. (Sharon Shattuck has contributed to The Times's Op-Docs forum.)

Marcia, a physician, was the primary breadwinner when Ms. Shattuck was young, and Michael was a stay-at-home father. At an early date, Michael told Marcia about his penchant for cross-dressing. Trisha explains how Marcia probably hoped the practice would stay in the bedroom. (They wed in 1981.) When Ms. Shattuck was around 8, she found a snapshot of her father in drag; explanations ensued. Michael eventually pursued a transition, with electrolysis, rhinoplasty and tracheal shave (reducing the Adam's apple), and still takes hormones. At Marcia's insistence, he stopped short of gender-reassignment surgery. Today, Trisha alternates between men's and women's clothing. A soft-spoken landscape architect, she plays guitar and banjo and paints semiabstract canvases with titles like "Split Personality" and "Joyous Woman Into Being." She and Marcia take walks and are physically intimate. In marriage and parenthood, one size doesn't fit all. Marcia's words at the wedding about surmounting differences speak volumes about love's adaptability." It is available by Netflix.

Two transgender women were present for the film and afterwards an honest, forthright discussion was held. Transgender is an issue that has been closeted for many years and now has become more openly discussed. The issue of postponing puberty was discussed as children grabble with feelings unknown to us. The more we educate ourselves the better we will be able to offer compassion and understanding to the men and women, boys and girls, who identify as transgender.

Please stay tuned for future programs on this delicate subject.



This workshop is designed to support white people in making the paradigm shift from 'fixing' and 'helping' those believed to be inferior, to focusing on internalized white superiority and its role in perpetuating racism at the individual, interpersonal, institutional, and cultural levels. This presentation includes pauses for reflection, dialog, and Q&A.

Debby Irving struggled to make sense of tensions she could feel but not explain in racially mixed settings over her 25 years as a teacher and community organizer in Cambridge, MA. A graduate school course in 2009, *Racial and Cultural Identities*, led to her understanding racism as a systemic issue and her own whiteness as an obstacle to grappling with it. Her book tells how she went from well-meaning to well-doing.


